

CBHI/CANS Interface Grant: Reason for Solicitation

CBHI / CANS

- Provider enters CANS data in their EHR system; information must then be printed out / re-keyed into the Virtual Gateway (VG) system
- Can take ~1½ hours to perform the initial CANS entry into VG and
 ~½ hour to complete and enter updates for each patient
- State continuing to invest in CBHI / CANS
 - EOHHS developed interface for CBHI application
 - HOWEVER, BH providers still require an interface from their EHR system to allow automatic transactions
- Leveraging Mass HIway to reduce administrative burden on BH provider organizations
 - Automatically upload reportable data from EHR system directly into EOHHS' database
 - Improve ability to deliver necessary care and eliminate redundant work/errors from re-keying data into state's Virtual Gateway system



Grant Overview and Interface Requirements



CBHI/CANS Interface Grant: Definitions

- EOHHS (Executive Office of Health and Human Services)
- CBHI (Children's Behavioral Health Initiative)
 - An interagency initiative of EOHHS
 - Ensure children with significant BH needs obtain necessary services
- CANS (Child and Adolescent Needs and Strengths) Assessment
 - Standardized BH assessment tool required of BH clinicians serving MassHealth children/youth
 - CANS used to track progress / revise plans



CBHI/CANS Interface Grant: Definitions (cont.)

Affiliated:

- Financial statements part of same consolidated financial statements, or
- One controls the other (directly or indirectly), or
- Are under common control
- Behavioral Health services
 - Direct patient care services by BH Providers
 - Used to evaluate/treat mental health and/or substance use disorders
 - Substance abuse treatment services must be approved DPH programs
- Behavioral Health Providers
 - Must provide direct patient care and
 - Be licensed clinicians or clinical staff authorized to provide direct patient care under the supervision of a licensed BH professional
- MeHI reserves right to further define Solicitation terms



CBHI/CANS Interface Grant: Overview

- Solicitation for Development of CBHI interface for CANS reporting
 - Applications from qualified BH EHR system vendors
 - To develop, test, and implement an HL7 interface that will:
 - Automatically extract data from the EHR system
 - Compile it according to MA EOHHS CBHI interface specifications, and
 - Submit it to the Commonwealth's system
- Incentive payments of up to \$60,000 per vendor to cover:
 - A portion of cost to both develop and test an HL7 interface that conforms to EOHHS' CBHI interface specification, and
 - The implementation and two years of related support service costs of this interface for a minimum of <u>three unaffiliated Mass organizations</u> providing BH services
- Applicants competing for limited number of awards
 - Applications evaluated pursuant to Solicitation evaluation criteria



CBHI/CANS Interface Grant: Interface requirements

- Must comply with all federal and state regulations
 - Including privacy, consent, and security issues
- HIway connection required to access CBHI interface
 - Transactions sent directly through Mass HIway or through a HISP connected to the Mass HIway
- Must coordinate interface / HIway testing with EOHHS
- Must coordinate any move to production with EOHHS
 - Following successful interface installation at BH organizations



CBHI/CANS Interface Grant: Interface requirements (cont.)

- Must conform to EOHHS interface specifications (attachments E and F have detailed specifications / workflow documents)
 - The Clinical Gateway (Rhapsody) will provide the pass through from a provider's System into the existing CBHI system
 - Via a custom interface
 - Using either a Web Service or Direct interface as an inbound transport method to the Clinical Gateway
 - All incoming CBHI messages that enter the Clinical Gateway from a provider's Health Clinical System will be processed according to existing business rules before being securely passed into the existing CBHI system



Milestone Payments



CBHI/CANS Interface Grant: Milestone Payments

Milestone 1 (50% of total incentive)

- Vendor completes development of an interface and tests with EOHHS' test system
- Vendor must coordinate testing with EOHHS
- EOHHS signs off that the interface has successfully tested and is error free

Milestone 2 (25% of total incentive)

- Achievement of the first identified BH customer successfully submitting, in production, to the CBHI application
- Vendor must coordinate both customer testing and move to production with EOHHS
- State certifies transaction from the customer has been received and successfully loaded into EOHHS' database



CBHI/CANS Interface Grant: Milestone Payments (cont.)

- Milestone 3 (25% of total incentive)
 - Achievement of the third identified BH customer successfully submitting, in production, to the CBHI application
 - Vendor must coordinate all customer testing and moves to production with EOHHS
 - State certifies transactions from the customers have been received and successfully loaded into EOHHS' database
- Payments based on Grantee meeting each of 3 milestones and incurring project—related costs at least as much as milestone payment
- Applicants expected to plan to successfully reach:
 - Milestone 2 by June 30, 2017 and
 - Milestone 3 by December 31, 2017

CBHI/CANS Interface Grant: Application Process

- The following <u>must</u> both be submitted by **December 12, 2016**:
- To: <u>proposals@masstech.org</u> by 3:00 p.m.
 - An <u>electronic version</u> (.pdf or .doc) of the Application, including the Authorized Applicant's Signature and Acceptance Form (Attachment E) and Attachments – with signatures
 - If the Application is submitted in pdf, a word (.doc) version of the Proposal Narrative should also be included
 - Include Solicitation number in email subject heading
 - To: MassTech office (Westborough) by 5:00p.m.
 - 1 bound <u>double-sided</u> copy of entire application package with original signatures



CBHI/CANS Interface Grant: Application Contents

- Application packages must include all of the following:
 - a) Executive Summary (2-pgs) of qualifications/proposed approach
 - b) Proposal Requirements including:
 - a. Description of the approach will use to complete the project and
 - A high-level project plan, including start and completion dates for each task listed in the Solicitation chart
 - c) <u>Letters of commitment</u> and support, including:
 - a. Applicant letter agreeing the 3 BH customers will not be charged implementation or software support fees for two years; and
 - b. Letters of support from the 3 BH organizations that they agree to participate with Applicant under this grant, including
 - Impact (# of monthly CANS transactions and estimated time entering in VG)
 - d) Supporting documentation, including:
 - a. List of BH orgs Applicant serves that submit CANS data
 - b. Verification is ONC certified vendor [complete Sec. 4.5(d) chart]



CBHI/CANS Interface Grant: Application Contents (cont.)

- e) Project Budget (Excel Template in Attachment C)
 - Applicant list of costs must include:
 - Amount BH provider would have paid for implementation and software development fees covered by this grant
 - Costs Applicant anticipates will not be covered by MeHI's grant and will be covered by the Applicant as a match
- ☐ A <u>narrative description</u> of estimated costs including:
 - a. Costs to develop the interface (cloud-based or on-premise);
 - b. Whether priced on subscription basis or one-time license fee;
 - c. Recurring fees to each org and what those services consist of;
 - d. Whether fees based on Org size and/or # of users;
 - e. Costs to test the interface with the Mass HIway per org; and
 - f. Costs to implement the interface in production for each org
- Additional documentation:
 - Authorized Applicant's Signature/Acceptance Form (Attachment B1)
 - Response Coversheet (see Attachment B2)



Eligibility and Evaluation Criteria



CBHI/CANS Interface Grant: Eligibility Criteria

Applicants must:

- Be a Health IT vendor with BH organization clients required to submit CANS assessments to CBHI through the Virtual Gateway
- Certify it has customers authorized to submit CANS data to the CBHI application
 - Applicants to provide list of BH organization customers to MeHI
 - MeHI will confirm authorization with EOHHS
- Applicant vendor's EHR must be an ONC certified health IT listed on CHPL; and
- Not have debarment status (state or federal)



CBHI/CANS Interface Grant: Evaluation Criteria

- Applicant selection will be based on the following criteria:
 - Impact on Commonwealth's ability to achieve its healthcare policy goals
 - Impact on the provision of BH care services to patients in MA:
 - Number of identified BH organization sites and/or providers who will have access to this interface
 - Estimated number of patients of each identified BH organization who will benefit from the interface
 - Number of CANS transactions that the identified BH organizations submit to EOHHS at the designated sites (MeHI will verify with EOHHS)
 - Willingness of the vendor to deliver the interface in the required timeframe
 - Preference given to Applicants who involve current eQIP BH grantees as at least one of their three identified BH organizations
- MassTech Collaborative reserves the right to consider such other relevant factors as it deems appropriate
